## **CAP. I. FIELD OF APPLICATION**

**Art. 1.** (1) This regulation establishes the general framework for the organization and operation of the Commission for student issues within the University of Life Sciences "King Mihai I" from Timisoara.

(2) The regulation applies to the members of the Committee for Student Affairs.

(3) Users of the regulation are responsible for applying and complying with the provisions of the documents in this regulation.

## **CAP. II. PURPOSE**

**Art. 2.** The purpose of the elaboration of this regulation is to establish unitary rules regarding the organization and operation of the Committee for Student Affairs in the University of Life Sciences "King Mihai I" from Timisoara (ULST).

## **CAP. III. DEFINITIONS. ABBREVIATIONS**

**Art. 3 .** IN n the content of this regulation will use the following **abbreviations**:

- **ULST** - University of Life Sciences "King Mihai I" from Timisoara.

## CAP. V. DESCRIPTION OF THE REGULATION

### CHAPTER V.1. GENERAL DISPOSITIONS

**Art. 6.** The objective of the Commission is to monitor compliance with the provisions of the regulations for the operation of the student dormitories, the student canteen within the University of Life Sciences "King Mihai I" from Timisoara, hereinafter referred to as ULST

**Art. 7.** The Commission operates on the basis of the legislation in force that regulates higher education, the University Charter and the present regulation, respecting the following principles:

- **objectivity** , in the sense that it bases its conclusions and proposals on the existence of objective facts;
- **active role** , acts in order to solve the problems found in the composition of the commission.

**Art. 8.** The Commission participates in the application of the provisions of the regulations for the functioning of the student dormitories, the student canteen, the internal regulations, the norms of the ULST University Charter and the legislation in force regarding the social problems of students.


### CAP. V.2. CONSTITUTION AND COMPOSITION OF THE COMMISSION

**Art. 9.** The Commission is established in compliance with the legislation in force in the field of higher education, the regulations for the functioning of student dormitories, the student canteen, the University Charter of ULST and other regulations aimed at the social problems of students.

**Art. 10.** (1) The commission is composed of 5 titular members of which: the president of the commission is the vice-rector with social and student activities, 1 vice-dean with student activities, the head of the Social Service, the administrator of the dormitory involved in the event and a representative of the student league from ULST.

(2) The Commission may be co-opted, when the situation requires it, as invited members, and other persons such as: the general administrative director, vice-deans with students, department directors, deans, other students, etc., to analyze or more effectively solve student problems that arise.

**Art. 11.** The President of the Commission summons the members of the Commission and the persons involved in the case to present and analyze some events/situations concerning the student dormitories or the canteen.

### **CAP. V.3. DUTIES OF THE COMMISSION**

**Art. 12.** Ensures the observance and application of the specific regulations for the operation of the student dormitories, the student canteen, as well as the internal regulations within the USVT

**Art. 13 .** The President of the Commission receives and archives the proposals, referrals, complaints, statements and all documents submitted by the persons concerned.

**Art. 14.** (1 ) The Commission adopts, after analyzing the complained issues, with the vote of the majority of the members present, under the conditions of the presence of at least two thirds of the total number of members, by open vote, sanctioning or proposing to sanction students who violate the rules of good behavior on campus and/or for the degradation or destruction of material goods in student dormitories, in the student canteen or in other ULST spaces (educational spaces, library, spaces greens, other ULST facilities, etc.).

(2) Each member of the Commission has the right to vote.

**Art. 15.** The commission draws up minutes of the meeting from which results the sanction to be applied or proposed for approval to the ULST Board of Administration, in accordance with the operating regulations of the student dormitories, the student canteen, and the University Charter of ULST This minutes will be signed by the Commission members participating in the debates. According to its attributions, the commission can also issue recommendations.

**Art. 16 .** The commission presents, through its president, to the Board of Administration of ULST, **the sanctions applied by it or the sanctioning proposals that will be subject to approval** and, as the case may be, also formulates proposals for the recovery of damages from the guilty students.

**Art. 17.** Sanctions applied or proposed by the Student Affairs Commission can be:

- a) written warning;
- b) exclusion from the dormitory until the end of the semester;
- c) exclusion from the dormitory for the entire academic year;
- d) the prohibition of the right to accommodation in ULST dormitories in the following academic year;
- e) the definitive loss of the right to accommodation in the ULST dormitories for the entire duration of the studies;
- f) expulsion without the right to enroll in any faculty within the ULST

**Art. 18.** Sanctions provided 17 LIT a) is applied by the Commission for Student Affairs, and those from letter b), c), d), e) and f) are approved by the Board of Administration, upon the proposal of the Commission for Student Affairs.
